About

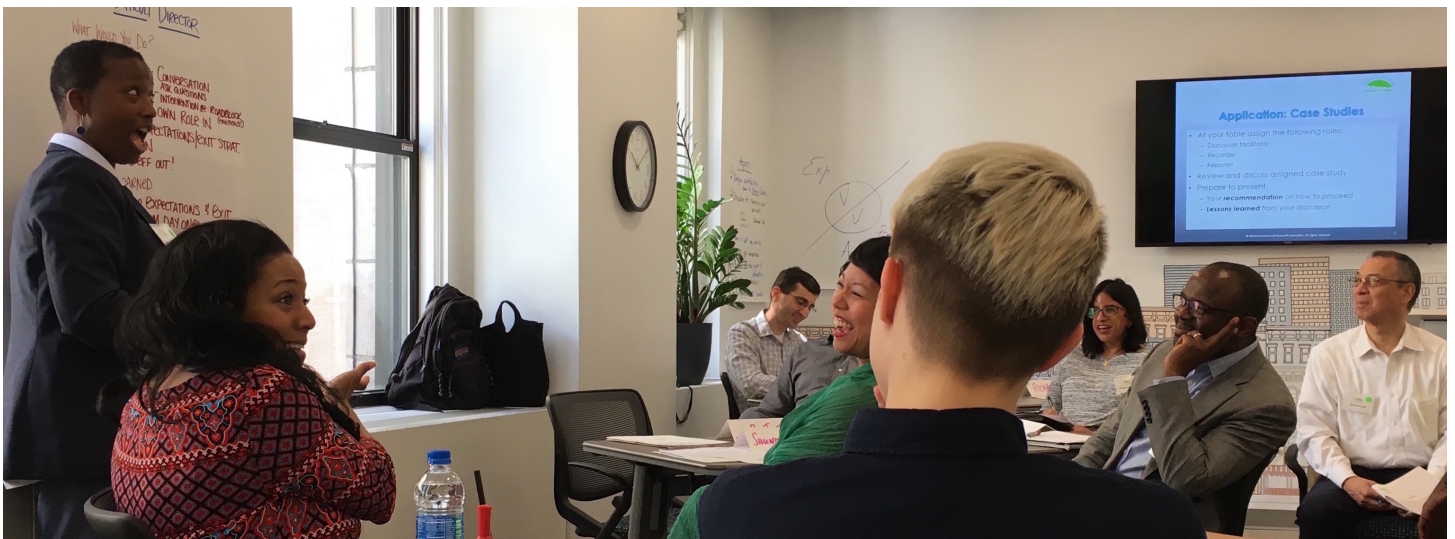

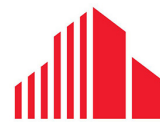

○ Education & Networking Events

Direct Reach: 40+ members and other nonprofit professionals per event



These public events - offered both virtually and in-person - bring consultants and other nonprofit leaders together to learn about important trends, share insights and create meaningful connections. Past events have focused on business development, DEI, and innovative ways consultants can and do support nonprofits and each other.

○ Consultant Circles

Direct Reach: 25+ members per convening



These virtual member convenings often include a brief spotlight on a member's area of specialty and their challenges and collaborative needs, followed by breakout discussions on rotating topics intended to build skills and community. The original Consultants Circle meets monthly, whereas the Strategic Planning, Marketing, and Interim Leadership Circles meet bi-monthly.

○ Public Workshops for Nonprofits

Direct Reach: 40+ nonprofit professionals per workshop



In conjunction with our capacity building partners, our public workshops attract nonprofit board members and professionals interested in building their organizational capacity around topics like strategic planning, fundraising, DEI, finance, and more. Expert facilitators from our membership will present to our partners' broad and diverse audience of providers.

○ MemberMatch Program

Direct Reach: 20+ members per cycle



Open to all members, this program pairs members with an “accountability partner” and provides the tools and prompts to guide discussions. Each member decides what they’d like to accomplish in 6 weeks, then shares those goals with their partner who cheers them on and holds them accountable.

○ Nonprofit Consultants Institute

Direct Reach: 15-25 current and emerging nonprofit consultants



This one-of-a-kind, 2-day intensive program covers key topics like business planning, accounting and marketing. For over 10 years, the Institute has positioned and empowered participants to create sustainable, thriving consulting practices that support the sector.
